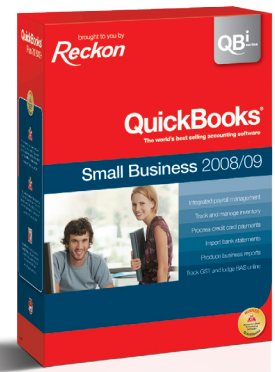
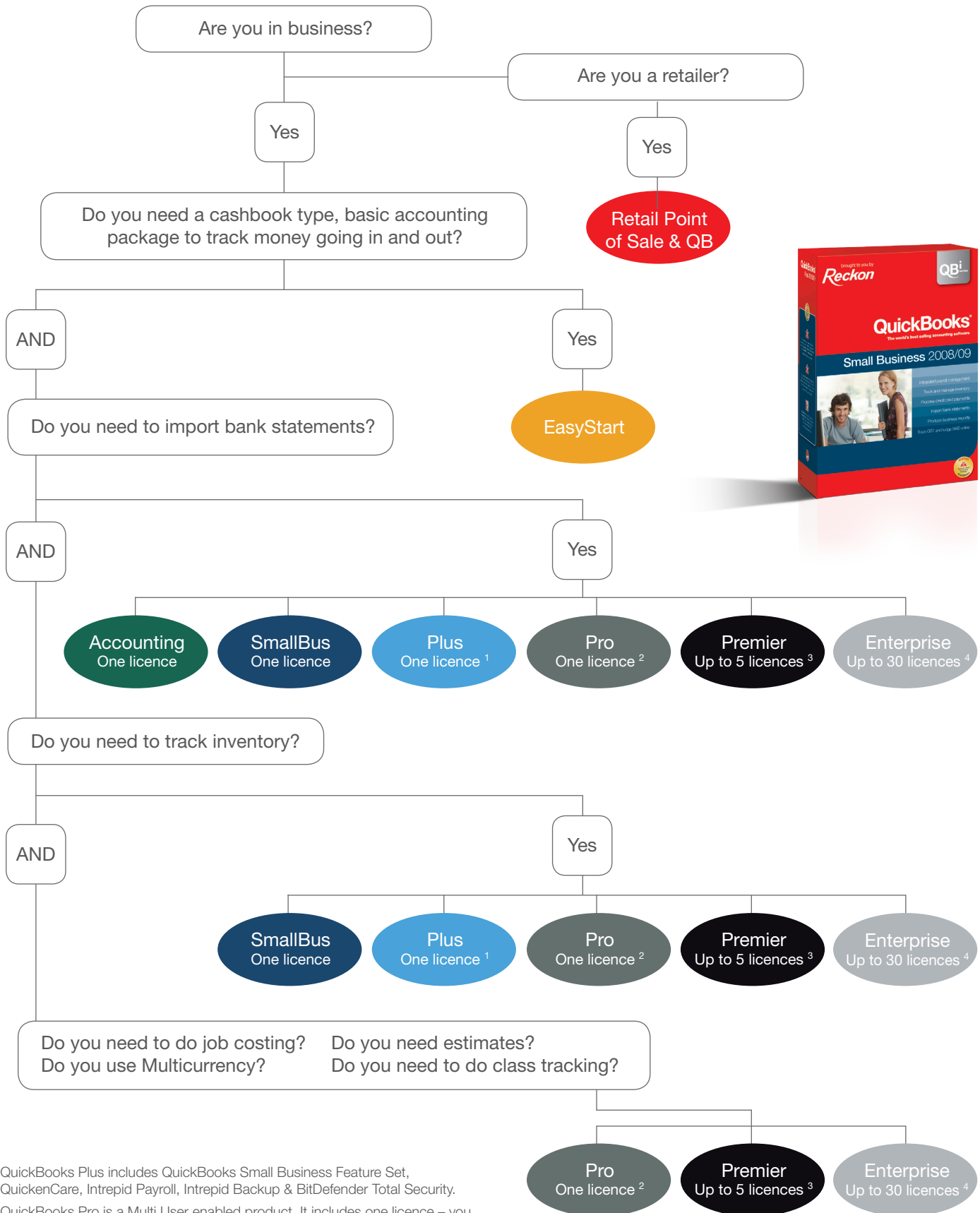


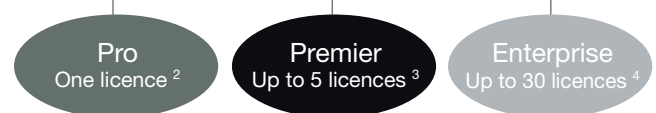
# QuickBooks® 2008/09

1. QuickBooks Plus includes QuickBooks Small Business Feature Set, QuickenCare, Intrepid Payroll, Intrepid Backup & BitDefender Total Security.
2. QuickBooks Pro is a Multi User enabled product. It includes one licence – you must purchase multiple copies for a multi user environment.
3. QuickBooks Premier is purchased with 3 licences. Additional licences can be purchased up to 5 consecutive users.
4. QuickBooks Enterprise is purchased with 10 licences and can be licensed up to 30.

Please note: There is no limit to the number of company files that you can create in QuickBooks. One licence refers to one installation per workstation.
